**RESERVATION APPLICATION AND AGREEMENT AND ENROLLMENT CONTRACT**

This Reservation Application and Agreement and Enrollment Contract (“Agreement”) is made as of the Effective Date (as hereinafter defined), by and between New Horizons Academy, a Nevada not-for-profit corporation (“School”), and \_\_\_\_\_ (individually or collectively, “Parent”).

1. **APPLICATION AND ADMISSION.** Parent hereby applies to School for the admission of \_\_\_\_\_, as a student for the academic year 2008-2009, and submits to School herewith payment of all Required Additional Fees in the amount of \$975.00 for the uses and purposes more particularly shown on Exhibit “1” to this Agreement. Subject to the terms and conditions of this Agreement, School (upon execution of this Agreement and delivery thereof to Parent) agrees to admit student as a student at the School for said academic year and to provide Student with educational services in accordance with (and subject to) School’s policies and procedures.

2. **AGREEMENT TO PAY TUITION AND REQUIRED ADDITIONAL FEES.** Parent has selected [PLEASE CIRCLE AND INITIAL ONE]:

for payment of tuition, which plans are more particularly described on Exhibit “1” to this Agreement, and hereby jointly and severally agrees to be legally bound to pay all sums for tuition (“Tuition”) contemplated by such payment plan, as well as all fees and costs designated as “Required Additional Fees”. Parent represents and warrants to School that the person(s) named above as “Parent” is/are the natural parents and/or legal guardians of Student.

3. **ADDITIONAL FEES AND/OR CONTRIBUTION OR SERVICES TO SCHOOL.** Parent acknowledges that School requires that Parent, in addition to the payment of the sums set forth elsewhere in this agreement, devote at least thirty (15) hours of services to programs at the School and/or benefiting the School. (Seven and one-half hours (7.5) hours only required for single parent households.) All such services must be to programs or activities approved by School as qualifying for fulfillment of this requirement. At least fifteen (15) such hours must be expended during the first semester. In lieu of performing such services, parent may elect to pay an additional \$150.00 in annual fees, payable \$75.00 at or before the end of the first semester. **All Parents will automatically be members of the New Horizons Parent/Teacher Organization.** The yearly dues are \$150.00. These dues may be paid by semester. These monies will be placed in the Parent/Teacher Organization account to be used solely for school purposes. In addition to any other rights of School hereunder, School shall have the right to refuse to furnish to any other school any transcripts or other evidence of Student’s attendance or performance at School until and unless all obligations to be performed pursuant to this paragraph have been met.

4. **CANCELLATION AND REFUND.** This Agreement may be terminated by Parent by written notice given to School on or before September 8, 2008. In the event of such termination, the amount paid by Parent, with respect to the Required Additional Fees, shall not be refundable, but any amounts paid by Parent with respect to Tuition, shall be refunded in full.

*Parent agrees and acknowledges that, because of the highly specialized educational services offered by School, School cannot readily replace students who leave prior to the completion of the academic year, whether voluntarily or as the result of suspension, expulsion, or dismissal of Student pursuant to paragraph 9 of this Agreement. Further, Parent agrees and acknowledges that, because School accepts a small number of students at the beginning of each academic year and plans its budget accordingly, the impact on School's operations from the withdrawal, suspension, expulsion or dismissal of any student would be disproportionately large if payment of the full Tuition and Required Additional Fees for the full academic year were not made. Therefore, Parent agrees and acknowledges that:*

- A. Parent is and shall be liable for the full amount of the Tuition and Required Additional Fees for the full academic year irrespective of the time of withdrawal, suspension, expulsion or dismissal of Student. This policy, with respect to cancellation and refund, is fair and equitable and was fully disclosed to Parent prior to Parent entering into this Agreement.*
- B. The Academy does not sub-divide tuition payments between divorced parents or get into the middle of any decreed financial judgments made by the courts.*

5. **LATE CHARGES.** All payments made, with respect to Plan "C", are due and payable by the 15<sup>th</sup> day of the calendar month. If any such payment, with respect to Plan "C", is not timely made, Parent agrees to pay an additional late charge in the amount of \$50.00 with respect to each payment not timely made. The second payment, with respect to Plan "B", shall be due on or before the last day of the first semester. If such payment, with respect to Plan "B", is not timely made, Parent agrees to pay an additional late charge of \$100.00 with respect to such payment.

6. **SCHOOL'S RIGHT TO SUSPEND STUDENT UPON NON-PAYMENT.** In the event that Parent fails to make any payment required pursuant to Plan "A" or Plan "B", or in the event that Parent fails to make any two or more payments required pursuant to Plan "C", School may, at its option and in addition to any other right or remedy which School may have, refuse to admit Student into any classes or activities and cease to provide educational services to Student until and unless all delinquent payments (and all late charges applicable thereto) have been paid in full. In addition, School shall have the right to refuse to furnish to any other school any transcripts or other evidence of Student's attendance or performance at School until and unless all delinquent payments (and all late charges applicable thereto) have been paid in full.

7. **DISHONORED CHECK.** In the event that any check offered in payment of any obligation of Parent hereunder shall be dishonored by the bank on which it is drawn for any reason whatsoever (whether rightfully or wrongfully), Parent shall pay a return check fee of fifteen dollars (\$30.00).

8. **WAIVER AND INDEMNITY.** Parent shall, at all times, be responsible for the actions and activities of Student, and shall be liable for, and shall save and hold School harmless from any claims, damages, liabilities, causes of action, or expenses of any kind or nature (including without limitation attorneys' fees) incurred or suffered by School as a result of any action of Student. Parent, for him/her/themselves and on behalf of Student, hereby releases School, its trustees, directors, officers, employees, and volunteers from any and all liability or obligation whatsoever which may arise out of any injury or sickness of any kind sustained by Student while in attendance at the School or while engaged in any School activity or activities, or while being transported to or from School or to or from any School activity, regardless of the cause or causes of any such injury or sickness.
